[A] GENERAL INSTRUCTIONS (Administrative Posts Only):

1. The minimum qualifications for the Posts of Registrar / Director of Physical Education & Youth Welfare / Librarian are as expressed by UGC Gazette, Notifications and G. R. of Govt. of Gujarat, Hemchandracharya North Gujarat University rules and subsequent amendments made therein.
2. A relaxation of 5% may be provided at the Graduate and Master's level for the Scheduled Caste / Scheduled Tribes / Differently abled (Physically and Visually differently abled) / Other Backward Classes (OBC/SEBC) (Non-Creamy layer) categories for the purpose of eligibility and for assessing good academic records during different recruitments where applicable. The eligibility marks of 55% marks (or an equivalent grade in a scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, **based on only the qualifying marks without including any grace marks.**
3. In the case of Director of Physical Education & Youth Welfare, the award of Degrees to Candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / By Laws / Regulations of the Institution awarding the Degrees and the Ph. D. subject to the fulfillment of the following conditions:-
 - a. Ph. D. Degree of the Candidate awarded in regular mode only;
 - b. Evaluation of the Ph. D. Thesis by at least two External Examiners;
 - c. Candidate had published two Research Papers out of which at least one in Referred Journal from out of his/her Ph. D. Work;
 - d. The Candidate had presented two Papers in Seminars/Conferences from out of his/her Ph. D. Work;
 - e. Open Ph. D. Viva Voce of the Candidate had been conducted.(a) to (e) above are to be certified by the Vice Chancellor /Pro-Vice Chancellor / Dean (Academic Affairs) / issued by Registrar
4. A relaxation of 5% marks may be provided from 55 to 50% marks to the Ph.D. degree holder who have obtained their degree prior to 19th September, 1991 for all those positions governed by the UGC regulations.
5. Candidates have to fill-in required information in the prescribed online application form from the website www.ngu.ac.in . It is mandatory to submit the Hard Copy (**plus one xerox copy of the same**) without which the application shall not be rejected.
6. If the space in the application form against any item is insufficient, separate sheet may be used.
7. Fees (Rs.500/- for General and Rs.250/- for SC/ST/OBC/EWS categories) should be paid online only. which is non-refundable.
8. The University reserves the right to fill the post or keep it vacant. In case of dispute / ambiguity/ interpretation the decision of Vice-Chancellor shall be final.
9. The applicant should ensure that the hard copy of application is submitted to the university through Speed Post or In person so as to reach the Registrar, Hemchandracharya North Gujarat University, University Road, Patan – 384265 on or before the due date.
10. Candidate if invited for interview will have to attend at his/ her own expense.
11. Candidates must enclose the attested or self-attested copies of relevant certificates, mark-sheets, documents, testimonials, etc.

They may submit one advance copy so as to reach the university on or before due date. A. REGISTRAR
